Introduction

This Privacy Policy of True Credits Private Limited (a company incorporated under the Companies Act, 2013 having its registered office at Huda City Centre Metro Station, 5th floor, sector – 29, Gurgaon, Haryana 122001, India and is the owner of the website https://www.truecredits.in/ (in any case, hereinafter referred to as "TC", "True Credits" "we", "our" or "us"), is an electronic record in the form of an electronic contract formed under the Information Technology Act, 2000 and the rules made thereunder and the amended provisions pertaining to electronic documents / records in various statutes as amended by the Information Technology Act, 2000. The term "you", "customer", "user", "borrower" denotes the person avails the services of True Credits by using the mobile application or through any other mode. This privacy policy does not require any physical, electronic, or digital signature.

This Privacy Policy is a legally binding document between you and True Credits. The terms of this Privacy Policy will be effective upon your acceptance of the same by availing its services. This Privacy Policy specifies the terms related to the management and handling of personal information of users (hereinafter referred to as "the Users") using the services of True Credits platform accessible through Mobile/Smartphone application (hereinafter "True Balance Application"). We understand that you entrust us with certain Information to help us provide various Services. In exchange for your trust, you expect and deserve our commitment to treat your Information confidential with respect and in accordance with the terms of this Privacy Policy ("Privacy Policy").

The Privacy Policy describes the policies and procedures followed by True Credits with respect to collection, use, share, disclosure and deletion of your Information and other data that we gather when you register for using True Balance Application and Services by creating a user account ("Account"), interact with other Users and third-party websites and services. The Company shall comply with all regulations on the protection of Personal Information specified in laws and regulations applicable to the Company.

A.Definitions

For the purpose of this Privacy Policy

- Account means a unique account or identifier created for you to access our Service or parts of our Service.
- **Application** means the software program provided by the Company downloaded by you on any electronic device, named True balance.
- **Company** (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to True Credits Private Limited, Gurgaon.
- Country refers to: India.
- State refers to: Haryana, India.
- **Device** means any device that can access the Service such as a computer, a mobile phone or a digital tablet etc.
- **Personal Data** is any information that relates to an identified or identifiable individual.
- **Service** refers to the loan product and/or other services provided on the Application.
- **Service Provider** means any natural or legal person who processes the data on behalf of the Company. B. Type of Personal Information collected and Purpose and Use of collection

Types of Data Collected

Personal Data

Name, Phone number, Email address, Geo-tagging, IP address, Device ID, Country of origin, Gender, Date of Birth, Financial information (such as Income, Income sources, bank account details etc.) One of Officially Valid Documents specified in RBI-KYC directions (Driving License, Voter's ID, NREGA Job Card, Passport, PAN, Aadhaar Card etc.), Deposit, charge and transaction information, and any other information and documents that you provide us to verify your identity or in terms of KYC (Know Your Customer) (such as copy of Aadhar card, PAN card, and/or Bank statement.

We do not collect or retain biometric data except where expressly permitted under applicable statutory provisions/law. However, facial data is captured and stored exclusively for the purpose of Video KYC, in accordance with and to the extent required by the KYC Master Directions given by Reserve Bank of India (RBI) or any other applicable law.

Also, once any loan has been granted to you, True credits may from time to time undertake your credit evaluation including accessing your bureau score, statement of accounts etc.

We may also collect information including but not limited to:

- Information about you when you register or when you use our Website and Application
- Credit related information that is collected from other sources like credit bureaus.
- Transaction history and details.
- Information that you provide when you write directly to us (including by e-mail) or connect with us over telephone.
- Aggregate information and electronic data like the pages viewed, how you navigate through the website and interact with webpages, etc.

You explicitly consent that one-time access can be taken by us of your camera, approximate location or any other facility necessary for the purpose of on-boarding/ KYC requirements only

True Credits website mobile app, written form, fax, telephone, e-mail, electronic board, promotional offer participation, customer support. Voluntary provision from the Users through service availing.

We may receive Personal information about you from third parties, such as social media services, commercially available sources and business partners. If you access Website through a social media service or connect a service on Website to a social media service, the information we collect may include your user name associated with that social media service, any information or content the social media service has the right to share with us, , and any information you have made public in connection with that social media service. When you access the Website through social media services or when you connect any Website to social media services, you are authorizing True Credits to collect, store, and use and retain such information and content in accordance with this Privacy Policy.

Usage Data

Usage Data is collected automatically when using the Service.

Usage Data may include information such as Your Device's Internet Protocol address (e.g. IP address), browser type, browser version, the pages of our Service that You visit, the time and date of Your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

When You access the Service by or through a mobile device, We may collect certain information automatically, including, but not limited to, the type of mobile device You use, Your mobile device unique ID, the IP address of Your mobile device, Your mobile operating system, the type of mobile Internet browser You use, unique device identifiers, Name and Version of system and application software; Other information collected at the time of installation: Installed applications on User's device and other diagnostic data.

Information Collected while Using the Application

While using the Application, in order to provide the uninterrupted lending services from the Application, the Company may collect, with your prior permission, information regarding, approximate location, device information, SMS, camera, WiFi connection information.

We use this information to provide features of Our Service, to improve and customize Our Service. The information may be uploaded to the Company's servers and/or a Service Provider's server, or it may be simply stored on Your device.

C. Term of retaining and use of personal information

Retention of your personal data

The Company will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of Our Service, or We are legally obligated to retain this data for longer time periods.

You may write to us in case you want us to remove your data from our records. We will ensure to fulfill your request subject to any requirement of retaining information as per applicable law.

Use of your personal data

The Company may use Personal Data for the following purposes:

Storage and Transfer of your personal data D.

Your information, including Personal Data, is processed at the Company's operating offices and in any other places where the parties involved in the processing are located in accordance with applicable laws. The Company ensures that your information, including Personal data, is processed and stored at servers located in India, in accordance with applicable laws.

The Company shall share the data with third parties in the manner as specially provided in this privacy policy.

However, the Company ensures that the third parties with whom your data is shared are compliant with the technology standards/ requirements on cybersecurity stipulated by RBI and other agencies, or as may be specified from time to time

Further, the Company ensures that data is shared with third parties only after receiving your explicit consent. Also, the applications gives the option to the customers to restrict sharing of the data with the Company and its partners.

The Company will take all steps reasonably necessary to ensure that Your data is treated securely and in accordance with this Privacy Policy and no transfer of Your Personal Data will take place unless there are adequate controls in place including the security of Your data and other personal information.

You further agree that such disclosure, sharing and transfer of Your Personal Information shall not cause any wrongful loss to You or to any third party, or any wrongful gain to us or to any third party.

You hereby unconditionally agree and permit that except as otherwise provided under this Privacy Policy, True Credits will disclose your Personal Information to third parties only in the following limited circumstances:

1. With Service Providers: We may share Your personal information with Service Providers to monitor and analyze the use of our Service, to contact You. We may store, share, disclose or part with all or any of your Information to various third party service providers / partners / banks and financial institutions for one or more of the purposes or as may be required by applicable law. In such a case we will contractually oblige the receiving parties of the Information to ensure the same level of data protection that is adhered to by True Credits under applicable law.
